Joanna Achille said they should differentiate between an accessory use or a commercial property. Goal is to allow something less restrictive for less cost that a commercial site for those doing agricultural business. Suggested making a recommended list that the board can waive requirements on, a Minor Agricultural Use for Non-Residential Primary Agriculture.

A motion was made to work on a theoretical shortening of the criteria with the Town Planner, seconded. Motion passed 5-0.
