E. Revising Prohibited Uses in Zoning Ordinances

Mike moved to review the list of Prohibited Uses in the Zoning Ordinance, Sec. 38-193. George seconded the motion. Motion passed, Mike, Warren, Helen, David, George, Anthony, aye. The following changes were recommended:

Remove from the list

- Airport or heliport to remain on the prohibited list; a private airstrip or helipad could be permitted by Special Use Permit
- "Any use which is obnoxious by reason of the emission of gasses, odors, noise, dust, vibration, or soot or by reason of the danger of fire or explosion" [Too broad.]
- Brewery or distillery move to permitted by Special Use Permit
- Commercial laundry (excepting a laundromat as provided for in section 38-191)- move to permitted by Special Use Permit
- Dormitory, except where accessory to a permitted use
- Vehicle washing shop (except where public sewerage disposal is available and/or except where utilizing a water reclaim system) move to permitted by Special Use Permit

The following uses were marked to be reviewed at a future meeting:

- Commercial facilities established for the purpose of storage, processing, or disposal of organic and non-organic waste
- Commercial slaughterhouse
- Racetracks of any description where a fee is charged or donations made (except as allowed under section 38-191)

The following uses were recommended for Permitted by Special Use Permit:

- Private airstrip or helipad
- Brewery or distillery
- Commercial laundry (excepting a laundromat as provided for in section 38-191)
- Vehicle washing shop (except where public sewerage disposal is available and/or except where utilizing a water reclaim system)

Mike moved and Warren seconded the motion to approve these changes, including removal of items (as listed above), and also to consider items for Allowed by Special Use Permit (as listed above). Motion carried, Motion passed, Mike, Warren, Helen, David, George, Anthony, aye.

Warren Ducharme moved and Mike seconded the motion to table items F-J until a future meeting. Motion passed, Mike, Warren, Helen, David, George, Anthony, aye.
