IV. WARRANTS Denise DiFranco moved, Jon Restivo seconded, to approve Payroll Warrant #47 for \$28,150.20.

a.) Bid Opening
Moosup
Valley Fire
Co., Fire
Engine

John L. Lewis Jr. stated that there were two bids received for the Moosup Valley Fire Company's Fire Engine. He proceeded to open the bids.

The first bid came from Rosenbauer New England LLC, 19 Summer St., Brunswick, ME 04011 for \$344,965.00.

The second bid was received from C and S Specialty Inc., 1181 Old Smithfield Rd., N. Smithfield, RI 02896. Mr. Lewis stated that there was a list of options that would change the price, but that the base price was \$372,948.00.

Gordon Rogers moved, Jon Restivo seconded, to refer the bids to the engineering board for their review.

Discussion: An audience member asked if there was a law stating how long a fire engine had to be kept in a town before resale or replacement and asked if we could keep a fire engine as long as we wanted. The town solicitor stated that she didn't know of any laws regarding this.

b.) Resolution In Opposition to H6100 Substitute A

Mr. Lewis asked the Town Planner, Juliana King, to briefly explain the resolution. Ms. King made note of the Right To Farm Act and explained that H6100A is legislation proposed to change a portion of the Right To Farm Act. The resolution was to oppose the changes because they opened the door to absolve non-agricultural, commercial activities on a farm from nuisance complaints without adequately defining a farm. There was lengthy discussion in favor of and against the resolution.

John L. Lewis Jr. moved, Denise DiFranco seconded, to adopt The Resolution In Opposition to H6100, Substitute A as it had been written.

John L. Lewis, Jr, aye; Denise DiFranco, aye; Gordon Rogers, nay; and Jon Restivo, nay. Motion failed 2-2.

c.) Liquidation of 2004 Ford F-150 Animal Control Truck

President John L. Lewis Jr. noted letters received from DPW Director Joe Cardillo, Police Chief William Ziehl, and the DPW Mechanic, recommending liquidation of the 2004 Ford F-150 Animal Control Truck by sending it to the scrap yard.

Gordon Rogers moved, Denise DiFranco seconded, to approve the recommendation of the DPW Director and the Police Chief to send the F-150 to the scrap yard.

John L. Lewis, Jr, aye; Denise DiFranco, aye; Gordon Rogers, aye; and Jon Restivo, aye. Motion carried 4-0.

d.) Conservation Commission Request to Plant Chest-Nut Trees With DPW Oversight Conservation member Ed Schernau informed the council of the efforts of The American Chestnut Foundation to try and restore the native American Chestnut Tree to the Eastern half of the country, by cross-breeding it with the Chinese Chestnut Tree. The Chinese Chestnut is immune to the blight that had originally decimated most of the American Chestnuts. The contract was discussed and reviewed briefly by the Town Solicitor.

Gordon Rogers moved, Jon Restivo seconded, to sign the agreement, move forward and get a couple of chestnuts growing on town property.

John L. Lewis, Jr, aye; Denise DiFranco, aye; Gordon Rogers, aye; and Jon Restivo, aye. Motion carried 4-0.

e.) Planning Board Appointment

Gordon Rogers moved to appoint Anthony Renzi to the Planning Board. John Lewis stated that Jon Restivo was recusing himself due to an application before the planning board at this time. There was no second, and the motion failed.

Denise DiFranco moved, John Lewis Jr. seconded to appoint Richard Sparks to the Planning Board.

Discussion: An audience member asked if Mr. Sparks was qualified for the position. Ms. DiFranco stated that she did not have his resume, but that she had seen it in the past and that he had been involved at the state level and was in finance as well as being a civil engineer. Mr. Rogers also stated that his resume was impressive.
