f.) Resolution Re: Employee Retirement System of RI, Amortization Schedule

Mr. Lewis reported that the Town had received a letter from the State allowing the town some options on the amortization of the pension settlement; the two options were for either a 21 year or 25 year payback schedule. If the Town takes no action, the State will automatically set the payback schedule for 25 years.

Treasurer Kelli Russ recommended that the town adopt a 21 year reamortization schedule, as the payments are very close to the existing Town and Police pension plan payment. Taking the 21 year schedule will not significantly impact operations and should not cost the town any additional funds.

Gordon Rogers moved, Roger Hawes seconded, that the Council send a letter of intent to remain on the current 21 year amortization plan for the employer reserve groups of Foster unit # 3012 and Foster police unit # 4082.

Denise DiFranco interjected that she had asked the solicitor if she needed to recuse from this vote; the answer had been no, she could vote.
