The November 10, 2016 Town Council Meeting was called to order by John L. Lewis, Jr., President of the Foster Town Council, at the Benjamin Eddy Building, Foster, Rhode Island, at 7:04 p.m.

II. ANNOUNCE-MENTS John L. Lewis, Jr. stated that the notice of the meeting was properly posted on the Secretary of State's web site.

Resident Walter May offered congratulations to the new Council members and wished a happy birthday to any marines in the audience. Mr. May then urged the incoming Council not to follow the lead of previous Councils by changing the DPW director every time the Council changes.

Mr. May stated that the Council is making the taxpayer pay a penalty every time the Council decides to change personnel, due to the learning curve that occurs with any new employee learning their job. Jobs should be changed only due to poor job performance, not at the whim of the Council.

c.) Web Site Presentation

Town Clerk Jane Christopher passed out paper samples illustrating the design for the new website currently in progress.

Ms. Christopher and Treasurer Kelli Russ outlined the difficulties inherent in managing the current web site computer program, particularly emphasizing the fact that the program was only licensed for one computer, creating a bottleneck.

The design and content of the new website will be easier for multiple department heads to update, will provide information in a more accessible way, act as a resource for residents, and include notification systems that residents can opt in to, and out of, at any time.

The new site is scheduled to go live in late January.

d.) Bid Award for Revaluation

Mr. Lewis asked Chief Ziehl for his recommendations. The Chief talked about the recent steps to fix the immediate problems with the radio back up system; but cautioned that a lightning strike could disable it. He recommended the digital microwave system as a more reliable way of ensuring good radio communications. Chief Ziehl recommended Cybercom as the preferred provider, both for price and their proven service reliability.

Cheryl Hawes moved, Denise DiFranco seconded, to honor the Chief's recommendation, and award the bid to Cybercom for \$15,713.37.

Discussion: Treasurer Russ cautioned that some of the money budgeted from contingency for a solution to the communications problems had already been expended for the emergency repairs recently completed. Ms. DiFranco asked if secondary wires could be fed through the new pipes to act as a backup. Mr. Rogers expressed his feeling that this project/expenditure should be put in front of the Planning Board as a capital expenditure.

John Lewis stated that there was a Public Hearing on the agenda pertaining to liquor licenses issued in the Town. Mr. Lewis read aloud the advertisement that was published for the liquor licenses.

That the Annual Fee for Sunday and Holiday Sales is Twenty-five Dollars (\$25) for each.
