Denise DiFranco moved, Roger Hawes seconded, to appoint Ed Schernau to the Conservation Commission for a period of three years.

d.) Appointment of Town Planner

Mr. Lewis reminded the Council that the Town Planner Interview Committee had been appointed, and that it was comprised of himself and Denise DiFranco representing the Town Council, Joe Walsh from the Zoning Board and Joe Carey and Tom Mercier from the Planning Board. A number of applicants had been interviewed the previous week. A unanimous decision had been made, and Denise DiFranco read the Committee's letter of recommendation to the Council, asking for the appointment of Juliana Berry King. (Exhibit B)

Denise DiFranco moved, Roger Hawes seconded, to appoint Juliana Berry King as the part time Town Planner commencing Monday, October 27, 2014.

VIII. OLD BUSINESS

a.)Bid Award, Two Trucks with Dump Bodies John Lewis read a letter from DPW Director Joe Cardillo announcing his recommendation of Putnam Dodge/Gates Auto Group of Columbia, CT, as the successful bidder for the two trucks with dump bodies in the total amount of \$118,862.00 delivered. (Exhibit C)

Denise DiFranco moved, Roger Hawes seconded, that the Council accept the recommendation of the DPW director to purchase two new dump trucks from Putnam Dodge/Gates Auto Group of Columbia, CT, in the amount of \$118,862.00 delivered.

Discussion: Neal Whitelaw asked if the cost for these trucks was coming from the capital budget, and questioned if it was the line item approved by the town residents at the Financial Town Meeting for one large 6-yard dump truck. Mr. Lewis responded that yes, the previous DPW director had made the

recommendation of a large truck, and it was the same item. Mr. Lewis also stated that, in the interim, two large military trucks have been obtained by the Police Department for eventual town use, and the current DPW director feels the town would be better served with two small trucks.

The Town Solicitor stated that there was nothing wrong with having gone out to bid. You could change the type or number of trucks purchased as long as the amount of money does not increase from that which was approved at the Financial Town Meeting.

Mr. Cardillo advised that these two new trucks would realize approximately a \$50,000.00 savings over the amount approved at the Financial Meeting.

Mr. Carey spoke for the Planning Board, which was part of the original approval process, and stated that the change from one to two trucks was not a problem with them.

Mr. Lewis stated that the \$50,000.00 savings would remain in the capital fund.

John L. Lewis, Jr. aye; Pamela Fontaine, abstained; Roger Hawes, aye; Neal Whitelaw, nay; Denise DiFranco, aye. Motion passed 3-1, one abstention.

b.)Contract Approval, CAST Grant

John L. Lewis, Jr. reminded the Council that they had approved Lorraine Kaul of CAST to proceed with the exploration of this grant. She had returned with a copy of the grant contract for signing. The town has been awarded \$335,000.00 for educational programs that deal with decreasing drug abuse in town.

Renee Bevilacqua stated that she would review the contract, to ensure all department heads know what their obligations are regarding the reporting criteria or anything else.

John L. Lewis, Jr. said that the Town has no obligation to put up matching funds, and that the Treasurer had stated that her office could handle their end of the reporting obligations.

Police Chief Bill Ziehl spoke in support of the grant.

Denise DiFranco asked if the solicitor could email the Town Clerk with her recommendation, and have the Town Clerk notify the Council afterwards.

Denise DiFranco moved, Roger Hawes seconded, to approve the contract for the Rhode Island Department of Behavioral Healthcare, Developmental Disabilities and Hospitals for the Partnership for Success/CASTgrant pending the judgment of the solicitor's review and approval of the contract.
