Denise DiFranco moved, Jon Restivo seconded, to accept the recommendation of the DPW director to postpone the project and review it again in the spring.

Council member Rogers stated that he had contacted two contractors about the repair project; one looked at the barn but had not yet responded to Mr. Rogers; the other contractor was still working on an estimate. Council President Lewis said that town resident Dick Colwell had given him an estimate as well, for basic restoration including sill replacement and repairing the foundation, of approximately \$50,000.00.

No action was taken; the topic will be revisited when Mr. Rogers receives the additional estimate.

c.) Revised Sign Regulations Ordinance/ Schedule Public Hearing

John L. Lewis, Jr. read the summary of the proposed sign ordinance revisions. (see Exhibit A) Mr. Lewis said that the only action required at this meeting would be to move the ordinance to the scheduled public hearing.

Denise DiFranco moved, Jon Restivo seconded, to move the proposed zoning ordinance for the sign regulations on to the public hearing on January 14th, 2016.

Mr. Lewis stated that the chairman of the Planning Board had requested to postpone the January 14th public hearing until after the upcoming special election to fill the vacant council seat, when there would again be a full council. Vice President DiFranco noted she would also be out of town on the 14th, and there would only be three council members present at that meeting.

The Council could choose at that time to not take a final vote until the January 28th meeting, after Vice President DiFranco had returned and had had the opportunity to listen to the audio files of the hearing, and add her vote.
